

## **PALMER POLICE PRESS RELEASES FOR** **July 11-17, 2022**

On July 11, 2022, Palmer Police arrested JASON D. EASTHAM, age 29 of Wasilla, on a \$2,000.00 warrant for Failure to Comply with Conditions of Release on an original charge of Burglary 2, Theft 2 X2, and Violating Conditions of Release. He was additionally charged with Criminal Trespass 2 and Violating Conditions of Release. He was remanded to Mat-Su Pretrial.

On July 11, 2022, Palmer Police arrested AMBER J. PETERSON, age 29 of Palmer, on a \$400.00 warrant for Failure to Comply with Conditions of Release, original charges of Disorderly Conduct, Criminal Trespass in the 2<sup>nd</sup> Degree, and Resisting Arrest. She was remanded to Mat-Su Pretrial.

On July 12, 2022, Palmer Police responded to the Palmer Airport for a report of smoke. Officers responding located a residence fully engulfed in flames off the Old Glenn Highway just east of Palmer Airport. An investigation into the start of the fire is on-going.

On July 12, 2022, Palmer Police responded to CARRS in Palmer for a report of an active fire in the parking lot. Following an investigation, ZACHARY S. MCKENNA-JOHNSTON, age 35 of Palmer, was arrested for Arson 1, Arson 2, Terroristic Threatening 2, and Criminally Negligent Burning. MCKENNA-JOHNSTON was remanded to Mat-Su Pretrial where he was held without bail, pending arraignment, per the bail schedule.

On July 12, 2022, Palmer Police Summons HOPE M. FULLER, age 43 of Palmer, for Criminal Trespass 2. FULLER was released from custody after the Summons was issued.

On July 14<sup>th</sup>, 2022, Palmer Police arrested CHARLES W. GILLILAN, age 40 of Palmer, on a warrant for Failure to Appear for the original charge of Criminal Trespass 2<sup>ND</sup>. GILLILAN was remanded and bail was set at \$50.00 per the warrant.

On July 15, 2022, at 1055hrs, Palmer Police Department arrested Larry THEODORE, age 57 of Wasilla, on a No Bond Warrant for Failure to Appear

for trial, original charge DUI. THEODORE was transported to Mat-Su Pretrial where he will be held without Bail.

On July 15, 2022, Palmer Police responded to the intersection of Evergreen Ave. and the Glenn Highway for a two vehicle Motor Vehicle Collision. The drivers were identified as REBEKAH LYNN MAILLY, age 19 of Palmer, and STORM KALE SHELDON, age 18 of Palmer. No injuries were reported at the scene.

On July 15<sup>th</sup>, 2022, Palmer Police arrested BERNT R. BISHOP, age 42 of Palmer, on a warrant for Failure to Appear for the original charge of Tamper with or Damage a Vehicle and one warrant for Failure to Appear on the original charge of Theft 4<sup>th</sup>. BISHOP was remanded to Mat-Su Pre-Trial and bail was set at \$500.00 per the warrants.

On July 17, 2022, Palmer Police forwarded charges to the Department of Juvenile Justice on a 12-year-old juvenile in Palmer for Assault 3 (DV) and Assault 4 (DV).
