

## **PALMER POLICE PRESS RELEASES FOR** **July 25-31, 2022**

On July 25, 2022, Palmer Police arrested ROBERT W. CONATSER, age 43 of Palmer, for a theft which occurred on July 24, 2022. He was arrested for Theft 2, Theft 2- Theft of Access Device, and Criminal Trespass 1. CONASTER was remanded to Mat-Su Pretrial where he was held without bail per the bail schedule.

On July 25, 2022, Palmer Police arrested TRISTAN R. RAGSDALE, age 22 of Palmer, on a \$2,500.00 warrant for Failure to Appear original charge Terroristic Threatening 1, a \$2,500.00 warrant for Failure to Appear original Charge Terroristic Treatening 2, and a \$2,500.00 warrant for Failure to Appear original charge Theft 4.

NIELSEN was remanded to Mat-Su Pretrial on no bail per the bail schedule.
