

PALMER POLICE PRESS RELEASES FOR **August 1-7, 2022**

On August 2, 2022, Palmer Police arrested BAILEY M. HALE, age 22 of Palmer, for two counts of Criminal Mischief 4, Theft 4, and seven counts of Criminal Trespass 2. HALE was remanded to Mat-Su Pretrial and held on \$1000.00 cash performance bail. The value of the stolen item was \$25.00 and the total damage was \$600.00.
