

## **PALMER POLICE PRESS RELEASES FOR** **August 22-28, 2022**

On August 22<sup>nd</sup>, 2022, Palmer Police arrested KENNETH J. LEWIS JR., age 36 of Anchorage, for Vehicle Theft 1<sup>st</sup>. KENNETH was arrested and remanded to Matsu Pretrial with no bail per the bail schedule.
