

## **PALMER POLICE PRESS RELEASES FOR** **September 26-October 2, 2022**

On September 26, 2022, Palmer Police arrested SHERIDAN T. PEGG, age 34 of Sutton, for Violation of Conditions of Release on the original charge of Assault 4 Domestic Violence, and Criminal Trespass 1<sup>st</sup> Degree. PEGG was remanded to Mat-Su Pre-Trial with no bail.

On September 27, 2022, Palmer Police responded to the intersection of Felton Street and Palmer Wasilla Highway for a three-vehicle motor vehicle collision. The drivers of the vehicles were identified as CATELYN A. MEDLEY age 17 of Palmer, HEATHER D. MEDLEY, age 38 of Palmer, and LOR S. THAO, age 29, of Palmer. No injuries were reported.

On September 27, 2022, Palmer Police responded to the intersection of Rowland Memorial Way and Palmer Wasilla Highway for a two-vehicle motor vehicle collision. The drivers of the vehicles were identified as VAUGHN A. SARTEN age 17 of Palmer, and HAYDEN C. BISHOP, age 19 of Sutton. Minor injuries were reported.

On September 28, 2022, Palmer Police arrested DEIRDRE C. FIKE, age 32 of Palmer, for Violating a Protective Order. She was remanded to Mat-Su Pretrial where she was held without bail.

On September 28<sup>th</sup>, 2022, Palmer Police arrested CAMERON S. KNIGHT, age 30 of KETCHIKAN, on a warrant for the original charges of Misconduct Involving Weapons 3<sup>rd</sup> and Misconduct Involving Weapons 5<sup>th</sup>. KNIGHT was arrested and remanded to Matsu Pretrial with \$250.00 bail per the warrant.

On September 28<sup>th</sup>, 2022, Palmer Police arrested JONNATHON S. STUDIE, age 31 of PALMER, for one charge of Escape 3<sup>rd</sup>. STUDIE was remanded to Mat-Su Pretrial with no bail per the bail schedule.

On September 30, 2022, Palmer Police filed charges with the District Attorney's Office on JOHNNY L. HAVIRD, age 45 of Anchorage, for Misconduct Involving a Controlled Substance 3, Misconduct Involving Weapons 2, Misconduct Involving Weapons 3, and Misconduct Involving a

Controlled Substance 5. These charges stem from an investigation which began in early September where HAVIRD was found to be in possession of over one half pound of methamphetamine pre-packaged and destined for sales in the Mat-Su Valley. A warrant has been requested by investigators for HAVIRD's arrest.

On September 30, 2022, Palmer Police assisted the Alaska DOC Pretrial Enforcement Division in the arrest of JOHN R. CLOYES, age 33 of Wasilla. CLOYES was remanded by the Pretrial Enforcement Division for charges of Violating Conditions of Release. Palmer Police additionally charged CLOYES with Failure to Stop at the Direction of a Peace Officer 2. CLOYES was held at Mat-Su Pretrial without bail, pending arraignment, per the bail schedule.

On October 1, 2022, Palmer Police sent charges of Criminal Mischief 5 to the Division of Juvenile Justice, against two 13-year-old male middle school students, for a vandalism incident which happened at Palmer High School.

On October 1, 2022, Palmer Police arrested KATHERINE L. PERRYMAN, age 30 of Palmer, on a \$20,000.00 Warrant for Failure to Appear on an Probation Violation.

On October 2, 2022, Palmer Police responded to a two-vehicle accident at Cobb St and Dahlia Ave. The drivers were identified as CAROL S. KAMMERMEYER, age 77, and NICHOLAS D. SMITH, age 17, both of Palmer. No injuries were reported.

On October 2, 2022, Palmer Police arrested NICHOLAS E. RUSSELL, age 31 of Eagle River, for Driving Under the Influence and two counts of Misconduct Involving a Weapon. RUSSELL was issued a summons for the charges per the bail schedule.
