

## **PALMER POLICE PRESS RELEASES FOR** **September 5-11, 2022**

On September 5, 2022, Palmer Police arrested MAURILIA S. SANCHEZ, age 18 of Palmer, for 2 counts of Assault in the 4<sup>th</sup> Degree and Disorderly Conduct. SANCHEZ was remanded to Mat-Su Pre-Trial on \$300.00 Bail.
