

PALMER POLICE PRESS RELEASES FOR **October 3-8, 2022**

On October 3, 2022, Palmer Police arrested AUSTIN LEN SLIZESKI, age 20 of Wasilla, for Driving Under the Influence. SLIZESKI was issued a Summons and released due to Mat-Su Pretrial current policies.
