

PALMER POLICE PRESS RELEASES FOR **October 17-23, 2022**

On October 17, 2022, Palmer Police arrested ATRETES T. OPHIER, age 35 of Talkeetna, on three no bail warrants for Failure to Remand on an Original Charge of Assault 4. He was remanded to Mat-Su Pretrial.

On October 17, 2022, Palmer Police arrested DYLAN C. BLAYLOCK, age 29 of Palmer, on a \$5,000.00 warrant for Failure to Remand on an Original Charge of Driving Under the Influence. He was remanded to Mat-Su Pretrial.
