

## **PALMER POLICE PRESS RELEASES FOR** **October 31-November 6, 2022**

On October 31, 2022, Palmer Police issued DAWSON S. LAPORTE, age 24 of Palmer, a Summons for Criminal Trespass in the Second Degree, after LAPORTE was contacted on property in Palmer he had previously been trespassed from.

On November 2, 2022, Palmer Police arrested JAMES L. COMPTON, age 27 of Palmer, on a \$350.00 warrant for Failure to Appear for Arraignment on the original charge of Driving while Canceled/Revoked/Suspended.

On November 2, 2022, Palmer Police arrested CRYSTAL R. PHILLIPS, age 35 of Juneau, on a \$250.00 warrant for Failure to Appear for Arraignment on the original charges of Providing False Information.

On November 2, 2022, Palmer police took a report of Trespass from Carrs in Palmer. Trespass 2 charges are being forwarded to the Palmer District Attorney against DAWSON S. LAPORTE, age 24 of Palmer.

On November 3, 2022, Palmer Police arrested ROSEBUD L. SWEENEY, age 32 of Palmer, for Trespassing 2 and Violating Conditions of Release. She was remanded to Mat-Su Pretrial, where she was released on her own recognizance per the bail schedule.

On November 3, 2022, Palmer Police responded to a report of a two-vehicle collision at E. Arctic Ave. near the Matanuska River Bridge. The drivers of the vehicles were identified as MAKAYLA BALDWIN, age 17 of Palmer, and ALEXIS BROOKS, age 36 of Wasilla. BALDWIN was transported to the hospital by ambulance.

On November 3, 2022, Palmer Police responded to a two-vehicle collision at the intersection of Bogard Rd. and Oscar St. The drivers were identified as SKLYER J. HARRISON, age 22 of Big Lake, and TABETHA L. MARSH, age 43 of Palmer. Minor injuries were treated on scene by EMS. No citations were issued.

On November 5, 2022, Palmer Police responded to a motor vehicle collision at the corner of E. Palmer-Wasilla Highway and the Glenn Highway. Investigation revealed ANDREW J. SNEDDEN, age 20 of Palmer, was driving a white Jeep behind ZACHERY T. CATO, age 26 of JBER, who was driving a white Chevy van, and struck CATO'S vehicle. No injuries were reported. Both vehicles were able to be driven away from the scene and no charges were filed, nor were citations issued.

On November 6, 2022, Palmer Police arrested JACOB D. OWENS, age 27 of Wasilla, on a \$25.00 warrant for Failure to Appear for Arraignment, original charge of Criminal Trespass in the 2<sup>nd</sup> Degree. He was remanded to Mat-Su Pretrial.

On November 6, 2022, Palmer Police arrested STERLING A. KLIPPENSTEIN, age 27 of Palmer, for two counts of Attempted Murder 1 (DV), two counts of Assault 1 (DV), two counts of Assault 2 (DV), two counts of Assault 3 (DV), four counts of Assault 4 (DV), one count of Robbery 1 (DV), one count of Robbery 2 (DV), two counts of Theft 2, and one count of Interfering with the Report of a DV Crime (DV). KLIPPENSTEIN was remanded to Mat-Su Pretrial where he was held without bail, pending arraignment, per the bail schedule.

On November 6, 2022, Palmer Police arrested DAWSON S. LAPORTE, age 34 of Palmer, for Criminal Trespass 2<sup>nd</sup> Degree. LAPORTE was also arrested on a \$25.00 warrant for Failure to Appear on the original charge of Criminal Trespass 2<sup>nd</sup> Degree.
