

## **PALMER POLICE PRESS RELEASES FOR** **November 28-December 4, 2022**

On November 28, 2022, Palmer Police arrested AARON R. LASHBROOK, age 32 of Palmer, for Criminal Trespass 2, Disorderly Conduct, and Violating Conditions of Release. LASHBROOK was remanded to Mat-Su Pretrial and held without bail pending arraignment per Magistrate O'Brien.

On November 29, 2022, Palmer Police arrested TORREY S. ANDERSON, age 31 of Palmer, on a \$10,000.00 arrest warrant for Failure to Comply with Conditions of Release on an original charge of Misconduct Involving Controlled Substances in the Second Degree. He was remanded to Mat-Su Pretrial.

On November 29, 2022, Palmer Police arrested MADISON R. UNGER, age 22 of Wasilla, for Assault 4. She was remanded to Mat-Su Pretrial where she was held without bail.

On November 29, 2022, Palmer Police arrested MARK R. WELLMAN, age 40 of Palmer, on a \$250.00 warrant for Failure to Comply with Conditions of Release on Original Charges of Disorderly Conduct and Violation of Conditions of Release. He was remanded to Mat-Su Pretrial.

On November 30, 2022, Palmer Police responded to a two-motor vehicle collision on E. Arctic Avenue near S. Alaska Street. The drivers were identified as MARSHALL H. TUCKER, age 20 of Palmer, and KELLY J. STRAWN, age 43 of Palmer. Investigation revealed STRAWN improperly negotiated a right-hand turn and struck TUCKER head on. Officers on scene noted STRAWN was displaying signs of impairment and investigated. STRAWN was ultimately arrested for Assault 3, Driving Under the Influence, and Refusal to Submit to a Chemical Test. STRAWN was remanded to Mat-Su Pretrial and held without bail, pending arraignment, per the bail schedule.

On December 1, 2022, Palmer Police arrested JESSIE E. MILLER, age 38 of Palmer, for Violating a Domestic Violence Protection Order. She was remanded to Mat-Su Pretrial with no bail per the bail schedule.

On December 2, 2022, Palmer Police issued a Summons to NORMAN M. GREIST, age 38 of Selawik, for Driving Under the Influence.

On December 2<sup>nd</sup>, 2022, Palmer Police arrested VICTORIA I. LAPORTE, age 27 of Palmer, for two warrants for Failure to Remand with the original charges of Theft 3<sup>rd</sup> and Criminal Trespass 1<sup>st</sup>, and Failure to Appear with the original charges of Conceal Merchandise and Trespass. LAPORTE was arrested and remanded to Mat-Su Pretrial with \$100.00 bail per one warrant and no bail per the other.

On December 2, 2022, Palmer Police issued a Summons to LINNUS A. DEPRIEST, age 64 of Palmer, for Criminal Trespass in the 2<sup>nd</sup> Degree.

On December 5, 2022, Palmer Police arrested a 35 year old Palmer male for Domestic Violence Assault in the Fourth Degree. The male was remanded at Mat-Su Pretrial on no bail per the bail schedule.

On December 5, 2022, Palmer Police issued a Summons to CAROLYN M. SOUTHARDS, age 36 of Palmer, for Driving Under the Influence.
