

## **PALMER POLICE PRESS RELEASES FOR** **December 5-11, 2022**

On December 5, 2022, Palmer Police issued a Summons to TEDDY F. VOS, age 19 of Palmer, for Criminal Trespass 2<sup>nd</sup>.
