

PALMER POLICE PRESS RELEASES FOR **January 2-8, 2023**

On January 2, 2023, Palmer Police issued a Summons to MICHAEL L LOMBARD, age 37 of Palmer, for Driving Under the Influence and Refusal to submit to a Chemical Test.

On January 2, 2023, Palmer Police arrested AARON R. LASHBROOK, age 32 of Palmer, for Criminal Trespass 2nd Degree. LASHBROOK was remanded to Mat-Su Pre-Trial with no bail.

On January 03, 2023, JESSIE E. MILLER, age 38 of Palmer, was arrested on two counts of Assault in the Third Degree, Criminal Trespass in the Second Degree, and Disorderly Conduct. No injuries were reported, and medical treatment was declined at the scene.
