

PALMER POLICE PRESS RELEASES FOR **March 20-26, 2023**

On March 20, 2023, Palmer Police arrested JOSEPH W. MCLAUGHLIN, age 23 of Palmer, on three warrants totaling \$450.00; Failure to Appear Change of Plea Hearing, original charge of Criminal Trespass in the 2nd Degree (2 cases), and Failure to Appear Change of Plea Hearing, original charge of Criminal Trespass in the 1st Degree. He was remanded to Mat-Su Pretrial.
