

PALMER POLICE PRESS RELEASES FOR **April 24-30, 2023**

On April 24, 2022, Palmer Police investigated a report of damage mailboxes at 112 S. Alaska St. The cost to repair the mailboxes is approximately \$850.00.

On April 24, 2023, Palmer Police issued a Summons to JOSEPH A. ZYWOT, age 37 of Wasilla, for Improper Use of Vehicle Registration.

On April 24, 2023, Palmer Police arrested ADAM M.
