

PALMER POLICE PRESS RELEASES FOR
June 12-18, 2023

On June 12, 2023, SKYLER L. BRAGG, age 42 of Wasilla, was arrested on the charge of Criminal Trespass in the Second Degree after he was contacted on property he had previously been trespassed from. BRAGG was remanded at Mat-Su Pretrial on \$250.00 cash performance bail per Judge Browning.

On June 12, 2023, Palmer Police arrested GARRY C. JACKSON, age 46 of Palmer, for Assault in the Forth Degree Domestic violence. JACKSON was remanded to Mat-Su Pretrial with no Bail per the bail schedule.

On June 13, 2023, Palmer Police arrested DANIEL AKHUMOV-KAZ, age 19 of Palmer, for an incident which occurred on June 12th. DANIEL was remanded to Mat-Su Pretrial on charges of Robbery in the 1st Degree, Theft in the 2nd Degree, and Assault in the 4th Degree. He was held without bail per the bail schedule.

On June 14, 2023, Palmer Police arrested MIAH M. JENKINS, age 25 of Anchorage, on a \$50.00 warrant issued for Failure to Appear at Pretrial Conference Hearing on the Original Charges of Two Counts of Criminal Trespass in the Second Degree. JENKINS was remanded at Mat-Su Pretrial.

On June 14, 2023, Palmer Police arrested KIMBERLY G. JORDAN, age 61 of Palmer, for Driving Under the Influence, Refusal to Submit to a Chemical Test and Reckless Driving. JORDAN was remanded to Mat-Su Pretrial where she was held until she was sober per the Bail Schedule.
