

**PALMER POLICE PRESS RELEASES FOR**  
**June 17-23, 2023**

On July 17, 2023, Palmer Police issued JORDEN E. SAYER, age 29 of Palmer, a Summons for Theft in the Fourth Degree and Criminal Trespass in the First Degree.

On July 17, 2023, Palmer Police arrested VICTOR MOLODKIN, age 41 of Wasilla, on a warrant for Failure to Remand, original charge of Felony Driving Under the Influence. He was remanded to Mat-Su Pretrial to serve time.
