

## **PALMER POLICE PRESS RELEASES FOR** **August 21-27, 2023**

On August 21<sup>st</sup>, 2023, Palmer Police arrested LOGAN J. ROBINSON, age 21 of Anchorage, for Driving Under the Influence and Misconduct Involving a Weapon in the Fourth Degree. ROBINSON was remanded to Mat-Su Pretrial where he was to be released on his own recognizance when sober, per the bail schedule.
