

PALMER POLICE PRESS RELEASES FOR **August 28-September 3, 2023**

On August 28th, 2023, Palmer Police summonsed BRANDON L. MILLER, age 41 of Anchorage, for the charge of Disorderly Conduct. MILLER was given a summons with a court date and released at the Palmer Police Department.

On August 29, 2023, Palmer Police arrested ZACKARY S. MCKENNA-JOHNSTON, age 36 of Palmer, for Robbery in the 1st Degree, Assault in the 3rd Degree, Assault in the 4th Degree, Harassment in the 1st Degree, Criminal Trespass in the 1st Degree, and Theft in the 4th Degree. MCKENNA-JOHNSTON was remanded to Mat-Su Pretrial where he was held without bail.

On August 30, 2023, Palmer Police arrested FRAGE T. SCHAEFER, age 29 of Palmer, for a \$100 arrest warrant for Failure to Appear on the original charges of Criminal Trespassing in the Second Degree, Resisting Arrest and Disorderly Conduct. He was remanded to Mat-Su Pretrial.

On August 30, 2023, Palmer Police arrested DANIEL M. GRAHAM, age 39 of Palmer, on a \$250 Cash Appearance arrest warrant from Palmer JS for Failure to Appear for Representation Hearing on an original charge of Guide/Aid in Commission of Violation Of Hunting Season and Bag Limits for Dall Sheep. He was remanded to Mat-Su Pretrial.

On August 31, 2023, Palmer Police arrested SIONE T. TALIAI, age 30 of Palmer, on a no bail arrest warrant from Palmer JS for Failure to Remand on the original charge of Theft in the Third Degree. He was remanded to Mat-Su Pretrial.

On September 1, 2023, Palmer Police forwarded charges of Misconduct Involving Weapons 5 to the District Attorney's Office on SEAN A. LOUGHLIN, age 18 of Talkeetna.

On September 1, 2023, Palmer Police arrested DAVID F. PETTY, age 43 of Wasilla, for Driving Under the Influence and Misconduct Involving a Weapon in the 4th Degree. PETTY was remanded to Mat-Su Pretrial where he was released on his own recognizance, per the bail schedule.

On September 2, 2023, Palmer Police arrested CALEB R. WOLFE, age 26 of Wasilla, for Driving Under the Influence and Failure to Stop at the Direction of a Peace Officer in the 2nd Degree. WOLFE was remanded to Mat-Su Pretrial where he was released on his own recognizance, per the bail schedule.

On September 2, 2023, Palmer Police took a hit & run report from a 17-year-old male, of Wasilla, that his vehicle had been struck by another vehicle at Evergreen Avenue and S Alaska Street. The driver of the other vehicle did not stop and exchange information. No injuries. Investigation continues.

On September 2, 2023, EMMA L. GREENWOOD-DORAN, age 33 of Palmer, reported to Palmer Police that she and her friend were assaulted with minor injuries by 2 adult females at the Klondike Mike's Saloon. Investigation continues.

She was additionally charged with Misconduct Involving a Controlled Substance in the 5th Degree. ODOMIN was remanded to Mat-Su Pretrial, per the bail schedule, the new charge would be release on her own recognizance.

On September 3, 2023, Palmer Police responded to the Alaska State Fair regarding a possible missing person. MARKIE WRIGHT, age 27 from Colorado Springs, Colorado was later found safe.

On September 3, 2023, Palmer Police arrested AARON R. LASHBROOK, age 33 of Palmer, for Criminal Trespass 2nd, after he was contacted on private property which he was previously trespassed from. LASHBROOK was remanded at Mat-Su Pretrial with no bail per Judge Bauer.

On September 3rd, 2023, Palmer Police conducted a traffic stop on a vehicle driven by WESLEY A. HANSEN, age 35 of Wasilla. An investigation resulted in HANSEN being arrested for Driving Under the Influence and Endangering the Welfare of a Child in the First Degree X2. HANSEN was processed for the DUI and remanded to MSPT without incident. He was to be released on his own recognizance when sober per the bail schedule or released to a sober third party.
