

PALMER POLICE PRESS RELEASES FOR **September 25-October 1, 2023**

On September 25, 2023, Palmer Police arrested LINNUS A. DEPRIEST, age 65 of Palmer, on a \$500.00 warrant for Failure to Comply on an original charge of Violation of Conditions of Release. He was remanded to Mat-Su Pretrial.

On September 25, 2023, Palmer Police received a report of theft of property from Palmer High School. Value of the stolen property was \$100.00, an investigation is ongoing.

On September 26, 2023, KIMBERLY A. KIRBY, age 69 of Palmer, reported her vehicle was the victim of a hit and run collision in the parking lot of Palmer CARRS. Estimated \$2000.00 in damage to the vehicle. investigation continues.

On September 27th, 2023, Palmer Police arrested GRADY A. LLOYD, age 48 of Houston, on one warrant for Assault in the 4th Degree. LLOYD was arrested and remanded to Mat-Su Pretrial with \$250.00 bail per the warrant.

On September 29, 2023, Palmer Police issued a Summons to DARLENE M. OLANNA, age 32 of Brevig Mission, for Driving While License Revoked and Avoidance of an Ignition Interlock Device.

On September 29, 2023, Palmer Police arrested TYLER W. KOWALCIK, age 23 of Palmer, for Driving Under the Influence and Driving While License Canceled. KOWALCIK was remanded to Mat-Su Pretrial where he was held on \$500.00 bail and not to be released until sober per the bail schedule.
