

PALMER POLICE PRESS RELEASES FOR **October 16-22, 2023**

On October 16, 2023, the School Resource Officer for Palmer Police took two reports of Misconduct Involving Controlled Substances 4 at Palmer High School. Reports for Misconduct Involving Controlled Substances 4 were sent to the Division of Juvenile Justice against a 16-year-old male student and a 15-year-old male student.

On October 17, 2023, Palmer Police responded to Bogard Road and Palmer Moose Drive for a reported motor vehicle collision. Investigation revealed a vehicle driven by JOHN C. BAKER, age 48, of Wasilla, struck a vehicle driven by JONATHAN B. NEISLER, age 32, of Wasilla. No injuries were reported at the scene and medical treatment was declined.
