

PALMER POLICE PRESS RELEASES FOR **November 20-26, 2023**

On November 20, 2023, Palmer Police issued a Summons to JOHN F. GEFFE, age 39 of Palmer, AK for Criminal Trespass in the Second Degree.

On November 20, 2023, Palmer Police investigated a report of a motor vehicle collision at Palmer Wasilla Hwy and Rowland Memorial Pkwy. The operator of the vehicles were identified as ETHAN R. SMITH, age 17 of Palmer, and KARI J. HOLSCLAW, age 50 of Wasilla. No injuries were reported and both individuals were using safety belts.
