

PALMER POLICE PRESS RELEASES FOR **December 4-10, 2023**

On December 4, 2023, Palmer Police Officers responded for an intoxicated male juvenile. After an investigation, AUSTIN C. SHIPLEY, age 22 of Palmer, was and issued a Summons to appear for Furnishing Alcohol to a Person Under 21 and released at the scene.
