

PALMER POLICE PRESS RELEASES FOR **January 1-7, 2024**

On January 1, 2024, Palmer Police Summoned REBECCA A. BOURQUE, age 40 of Palmer, for Criminal Trespass in the 2nd Degree.

On January 4, 2024, Palmer Police arrested PAUL W. REED, age 34 of Palmer, for Driving While License Revoked, Avoidance of an Ignition Interlock Device and No Motor Vehicle Liability Insurance. REED was issued a Summons for each offense with a court date set and released at the scene.
