

PALMER POLICE PRESS RELEASES FOR **January 22-28, 2024**

On January 23, 2024, Palmer Police responded to the intersection of Anna St. and W. Auklet Ave for a motor vehicle collision. The drivers of the vehicles were identified as CHARLENE F. VAUGHN, age 66 of Palmer, and KIMBERLY J. CROWLEY, age 40 of Palmer. No injuries were reported. No citations were issued.

On JANUARY 23, 2024, Palmer Police responded to and Motor Vehicle Accident near the intersection of Palmer Wasilla Highway and Glenn Highway. The drivers of the vehicles were identified as DANIEL NORBO, age 64 of Palmer, and NICHOLAS MAINES, age 22 of Fairbanks. No injuries were reported. Both vehicles were driven away from the scene.

BEHLKE was remanded to Mat-Su Pretrial, where he was released on his own recognizance per the bail schedule.
