

PALMER POLICE PRESS RELEASES FOR **January 29 – February 4, 2024**

On January 29, 2024, Palmer Police issued a summons to MIAH JENKINS, age 25, of Palmer, AK, for the charges of Criminal Trespass.

On January 29, 2024, Palmer Police arrested MITCHELL A. CANNON, age 32 of Wasilla, on a misdemeanor arrest warrant for Failure to Appear on an original charge of DUI. He was remanded to the Matsu Pretrial Facility. His bail was set at \$700.00 cash per the warrant.

On January 30, 2024, BRANDON B. KEAGY, age 34 of Palmer, turned himself in to Palmer Police on a \$100.00 warrant issued for Failure to Appear at Trial Call for the original charge of Operating Under the Influence. KEAGY was remanded to Mat-SU Pre Trial.
