

## **PALMER POLICE PRESS RELEASES FOR** **February 5-11, 2024**

On February 06, 2024, Palmer Police arrested GUILLERMO E. QUINONEZ, age 33 of Palmer, on the charge of Criminal Trespass 2<sup>nd</sup>. QUINONEZ was remanded at Mat-Su Pretrial on \$100.00 bail per Judge Traini.

On February 6, 2024, Palmer Police responded to the intersection of Glenn Highway and W. Arctic Ave. for a report of a Motor Vehicle Collision.
