

## **PALMER POLICE PRESS RELEASES FOR** **February 12-18, 2024**

On February 14, 2024, Palmer Police arrested AARON K. DOLLISON II, age 32 of Palmer, on a \$100.00 warrant issued for Failure to Appear at Pretrial Conference Hearing on November 15, 2023, on the Original Charges of Vehicle Theft 1st, Theft 2<sup>nd</sup>, Failure to Stop at the Direction of a Peace Officer and Reckless Driving. DOLLISON was remanded at Mat-Su Pretrial.
