

## **PALMER POLICE PRESS RELEASES FOR** **March 25-31, 2024**

On March 26, 2024, Palmer Police arrested ERNEST G. ALAMEDA JR., age 50 of Anchorage, for Failure to Stop at the Direction of a Peace Officer in the First Degree, Failure to Stop at the Direction of a Peace Officer in the Second Degree, and Reckless Driving. He was remanded to Mat-Su Pretrial, per the bail schedule.

On March 25, 2024, Palmer Police arrested ERNEST G. ALAMEDA JR., age 50 of Anchorage, on a \$250.00 arrest warrant for Failure to Appear on an original charge of Forgery in the Second Degree. He was remanded to Mat-Su Pretrial.

On March 26, 2024, Palmer Police arrested ANTHONY A. HAYS, age 71 of Palmer, on an arrest warrant for Failing to Appear for Pre-Trial Conference Hearing on an original charge of Leaving the Scene of an Accident. His bail was set at \$500.00.

On March 26, 2024, Palmer Police arrested Guillermo Quinonez age 33 of Palmer, for a \$500.00 Failure to Appear warrant for Criminal Mischief in the third.

On March 28th, 2024, Palmer Police Department arrested LINNUS DEPRIEST, age 66 of Palmer, on a warrant for Failure To Appear, original charge Criminal Trespass. DEPRIEST was remanded to Mat-Su Pretrial with bail set at \$25.00 per the warrant.

On March 29, 2024, Palmer Police Department arrested GUILLERMO QUINONEZ, age 33, of Palmer, for Disorderly Conduct, Criminal Trespass, and two counts of Violation Of Conditions Of Release. A bail of \$250.000 cash performance, and \$100.000 cash appearance were set by the on-call judge. GUILLERMO was remanded to Mat-Su Pretrial.

On March 29, 2024, Palmer Police responded to the intersection of Daron Drive and Palmer-Wasilla Highway for a motor vehicle collision. The drivers were identified as DONALD J. MALONE, age 71 of Palmer, and CAROLE A. WEST, age 68 of Palmer. No injuries were reported. Both vehicles received only minor damage and were able to be driven from the scene.

On March 30, 2024, Palmer Police arrested SIMONE C. A. PECORA, age 33 of Valdez, on a \$1000.00 warrant for Violation of Conditions of Release on the original charge of Misconduct Involving a Controlled Substance in the Second Degree, and a \$500.00 warrant for Failure to Appear for Calendar Call on the original charge of Misconduct Involving a Controlled Substance in the Second Degree and Driving Under the Influence. PECORA was remanded to Mat-Su Pretrial.
