

PALMER POLICE PRESS RELEASES FOR **April 8-14, 2024**

On April 8, 2024, Palmer Police arrested KAYLE V.H. KAVAIRLOOK, age 18 of Koyuk, for DV Assault in the Third Degree and DV Assault in the Fourth Degree. He was remanded to Mat-Su Pretrial without bail.

On April 8, 2024, Palmer Police arrested ZAKK M. SCHUERCH, age 35 of Anchorage, for Criminal Trespass in the Second Degree. His bail was set at \$50.00 per Judge Traini. He was remanded to the Matsu Pretrial Facility.
